

600 Campaign Sports Campus Pitch Lottery

Terms and Conditions

1. The Pitch Lottery is being run by the 600 Campaign, Royal Latin School, Chandos Lane, Buckingham, MK18 6AE
2. Entry to the Pitch Lottery deems that you have accepted the Terms and Conditions of this offer.
3. We do not accept responsibility for entries (ticket purchases) lost, mislaid, stolen, unprocessed or otherwise, regardless of cause, eg. human error, technical failure.
4. The prize draw is open to entrants over 16 years of age.
5. In entering the lottery, you confirm that you are eligible to do so and eligible to claim any prize you may win.
6. Entry to the Pitch Lottery is actioned by buying a Pitch Lottery Ticket through our online shop: <https://www.royallatin.org/600-events/pitch-lottery/>. These are numbered uniquely using alpha-numeric characters and there are 600 available in total.
7. Upon purchase, you can select the alpha-numeric combination you would like to buy. This corresponds to a “square” of the RLS 3G pitch.
8. There is no limit to the number of Pitch Lottery tickets you can buy, as long as they are in stock.
9. Each individual “square” is unique and can only be bought once, by one entrant.
10. When a “Pitch Square” is bought, it will belong to the owner for the entirety of the lottery period and will not be made available for sale again.
11. There will be 6 prize draws during the lottery period. The first will be made when the first 100 squares have been sold. The second when 200 squares have been sold. Also when 300, 400, 500 and 600 squares have been sold.
12. On each Draw, a winner will be selected using a computer-generated random process.
13. The winner of each of the 6 Draws will win £100, PLUS a framed piece of original 3G astro turf from the Royal Latin School Sports Campus. These are pieces of astro “cut-offs” from the original set, laid in June-July 2020.

14. The winner will be notified by email, within 7 days of The Draw, to the email address provided during purchase.
15. The prize is non-exchangeable, non-transferable and no alternatives will be offered.
16. We reserve the right to substitute prizes with another prize of equal or higher value if circumstances beyond our control make it necessary to do so.
17. Payment of the cash prize will be made by cheque or BACS transfer. The framed astro turf will be available to collect from the main school reception at a mutually beneficial time.
18. By entering the Pitch Lottery, you consent to any personal information you provide in entering being used by TLC for the purposes of administering the prize draw.
19. If you are selected as one of the winners of the Pitch Lottery, you agree to participate in any promotions relating to the promotion, within reason, including announcement on social media, the website and other forms.
